POLICE REPORT
POLICE CHIEF ROBERT
WAHWASUCK

Police Chief Robert Wahwasuck was in attendance to provide the Commission with an update of Police Department activities. Police Chief Wahwasuck also reminded the Commission that at the July 13, 2015 Commission meeting there was discussion on creating 4-Way stops at the intersection of 14th & Oregon and 9th & Jefferson. At that meeting it was decided to revisit the 14th & Oregon intersection in 6 months and to leave the intersection at 9th & Jefferson as is. Police Chief Wahwasuck has done some traffic studies at the 14th & Oregon intersection with no accidents during the 6 month time period. The Commission was agreed with Police Chief Robert Wahwasuck that the intersection at 14th & Oregon will remain as is.

ORDINANCE #1502
½ CENT SALES TAX

Commissioner Nick Aberle made a motion to approve Ordinance #1502. An ordinance levying a retailers's sales tax in the amount of one-half of one percent (0.5%) within the City of Sabetha in accordance with the provisions of K.S.A. 12-187 Et. Seq., and K.S.A. 12-189. Commissioner Kenny Miller seconded the motion. The motion was carried 4 – 0.

CHARTER ORDINANCE
#19. GOVERNING BODY
VACANCIES

Mayor Doug Clark made a motion to approve Charter Ordinance #19. An ordinance exempting the City of Sabetha from the provisions of L. 2015, Chapter 88, Section 71 relating to the filling of governing body vacancies. Commissioner Nick Aberle seconded the motion. The motion carried 4 – 0.

HOUSING AUTHORITY
BOARD APPOINTMENTS

Mayor Doug Clark asked for a motion to approve the Mayor's appointment of Stan Remmers to replace Nick Montgomery and Ruth Wisemiller to replace John Carlson on the Housing Authority Board. Commissioner Kenny Miller made the motion and Commissioner Nick Aberle seconded the motion. The motion carried 4 – 0.
